Nadeen's practice is focused on commercial litigation and appellate law. She provides litigation support at all stages of trial court proceedings and representation in both civil appeals and mandamus proceedings.

Prior to joining GCAK, Nadeen worked as a briefing attorney and staff attorney for Chief Justice Rebeca Martinez at the Fourth Court of Appeals. Her duties included advising the justices regarding resolutions of complex issues within appeals and original proceedings.

Nadeen was recently recognized as a Rising Star Honoree by the State Bar of Texas' Texas Minority Counsel Program. She participated in the 2020 Hispanic National Bar Association Latina Leadership Academy and is a graduate of the 2022 Bexar County Women's Bar Foundation's LEAD Academy, which focuses on helping women excel in their law practices.
