**REPRESENTATIVE EXPERIENCE:**

- Represented a defendant/counter-plaintiff defending more than \$9 million in claims in a multi-week jury trial in a case involving breach of contract and fraud. Jeffrie served as co-counsel in obtaining a complete defense verdict where the jury returned a take nothing judgment against plaintiffs and awarded the defendant damages and all attorneys' fees on counterclaims.
- Obtained complete defense verdict for individual and LLC defendants in a 1.5 week jury trial in a case involving claims of tortious interference with a contract.
- Drafted an extensive motion for application of Mexican Law in a case involving breach of contract, breach of fiduciary duty, and fraud where plaintiffs sought more approximately \$1 billion in damages, which resulted in the Court granting the motion and a take nothing judgment being entered against plaintiffs. After plaintiffs appealed the application of Mexican law, Jeffrie drafted the appellee's brief in the intermediate court of appeals, resulting in the court upholding the trial court's ruling on the application of Mexican law and concluding a 10+ year matter.
- Briefed successful mandamus action in intermediate appellate court overturning the trial court's denial of a defendant's motion to designate responsible third party.
- Drafted successful response brief in mandamus action where opposing party sought to overturn the trial court's ruling granting defendant's motion to designate responsible third party. In a written opinion, the intermediate appellate court upheld the trial court's ruling. Relators sought review of the Texas Supreme Court, which was denied.

- Assisted in drafting a brief in response to motion to stay in a bankruptcy appeal which resulted in a favorable verdict and the district court dissolving the stay pending appeal.
